POSITION DESCRIPTION

It is anticipated there will be a need for Pre-Six Lecturers to teach lower-division courses in the Department of Physics and Astronomy during the 2023-24 academic year. Appointments are subject to availability of funding and final approval by the Dean of the College of Letters & Sciences.

Qualifications: M.S. in physics or physics-related field is required. PhD in physics or physics-related field strongly preferred; college and/or university teaching preferred.

Description of Duties: Duties will include teaching in lower division physics and/or astronomy lecture courses and labs.
